

**FIRST AMENDMENT TO THE HEALTH SERVICES AGREEMENT AT  
PASCO COUNTY, FLORIDA  
(Effective January 1, 2017)**

This First Amendment, effective January 1, 2017 (this "Amendment"), to the Agreement for Inmate Health Care Services, dated October 1, 2016, (the "Agreement") is by and between Correct Care Solutions, LLC ("CCS") and the Pasco Sheriff's Office ("PSO").

**WHEREAS**, the Agreement requires CCS staff to be in compliance with certain PSO regulations pursuant to Section 2.7; and

**WHEREAS**, the Parties agree to amend one of the regulations cited in the last paragraph of Section 2.7, specifically replacing PSO General Order 22.8 with PSO General Order 22.15, pursuant to Section 9.4; and

**WHEREAS**, in accordance with Section 9.4, the Parties desire to amend the Agreement to memorialize such changes.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:


1. **RECITALS.** The Parties hereto incorporate the foregoing recitals as a material portion of this Amendment.
2. **AMENDMENT TO SECTION 2.7 OF AGREEMENT.** Effective January 1, 2017 the Agreement shall be amended by deleting the last paragraph of Section 2.7 in its entirety and inserting the following language in lieu thereof:
  - All CCS staff must adhere to PSO General Order 22.15 Uniform and Personal Appearance and PSO Order 22.9 Smoke and Tobacco – Free Workplace. CCS shall have 90 days to ensure all employees comply with the said General Orders.
3. **SEVERABILITY.** If any terms or provisions of this Amendment or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Amendment or the application of such term or provision to person or circumstances other than those as to which it is held invalid or unenforceable shall not be affected thereby and each term and provision of this Amendment shall be valid and enforceable to the fullest extent permitted by law.
4. **DEFINITIONS.** Capitalized terms used but not defined herein shall have the meaning ascribed to them under the Agreement.

5. **REMAINING PROVISIONS.** The remaining provisions of the Agreement not amended by this Amendment shall remain in full force and effect.

**IN WITNESS WHEREOF**, the Parties have caused this Amendment to be executed in their names or their official acts by their respective representatives, each of whom is duly authorized to execute the same.
