SCHOOL CONTACTS

Your child's school may be the first contact for help for your child's problems. Staff at the school who may be able to help you or direct you to help include the Principal or Assistant Principal, Guidance Counselor, School Social Worker, School Psychologist, or School Nurse. Many schools also offer counseling groups for students, as well as support groups and parenting training.

Every middle school and high school, within the county also have School Resource Officers. These law enforcement officers are assigned to the school campus and are available to assist you in a variety of different ways.

In addition to the school, you may also contact the District School Board offices in Land O' Lakes. They can direct you to the appropriate staff member at your child's school who can help you with your child's needs. DEPARTMENT OF JUVENILE JUSTICE

The Florida Department of Juvenile Justice is a state agency that provides programs and services on a local level. DEALING WITH RUNAWAYS

Running away from home is a relatively common behavior for adolescents. Most of the time the child will return home rather quickly, or the parent may know the whereabouts of the child. If the parent knows the location of their child, they should make an attempt to get the child. If a parent doesn't know the location of their child or the child is clearly refusing to return home, law enforcement should be contacted. There is no waiting period for reporting runaways, but the parent should use common sense in making the decision to declare their child a runaway. Once reported, a deputy will conduct a preliminary investigation to gather information and attempt to locate the child. Information such as clothing, description, past occurrences, and known acquaintances will be helpful. A recent photograph is also requested, if available. If the deputy doesn't

locate the runaway by the end of the shift, their report will be forwarded to the Juvenile Investigations Unit for logging and any follow-up. If a parent learns the location of their child, they should attempt recovery if possible, or contact the Sheriff's Office for assistance. In any event, when a runaway returns home, law enforcement must be notified in order to document the child's safety and to cancel all computer entries showing the child as a runaway.

The RAP House (Runaway Alternative Program) is a local alternative for juveniles who are considering running away from home. Other resources related to runaways include the National Center for Missing and Exploited Children at 1-(800) 843-5678, and the National Runaway Switchboard at 1-(800) RUNAWAY (786-2929).

TRUANCY

Truancy is a very serious issue, which can quickly lead to other illegal or dangerous behavior by young people. Chronic truancy can also lead to parents being criminally prosecuted or the child being referred to court as well. By Florida law, parents are responsible for ensuring that their children are registered for school according to the local school calendar, and that the child arrives on time and attends on a regular basis. Parents must set clear rules regarding school attendance and encourage a lifestyle that promotes regular attendance and academic success.

If truancy problems do arise, especially with older children, there are agencies listed in this guide that can help you deal with these situations.

UNGOVERNABLE BEHAVIOR

Every child will sometimes display inappropriate or rebellious behavior. It is when they refuse to respond to parental authority or consequences over a period of time or they begin to engage in harmful or illegal behavior that outside assistance may be needed. Children who refuse to attend school, who runaway, or who otherwise fail to comply with reasonable parental demands place themselves at risk for a variety of harmful consequences. It is important that parents seek assistance in dealing with such behavior once they feel they are losing control of their child's behavior.

Several of the agencies listed in this guide can be of assistance in helping families deal with a child's ungovernable behavior.

CINS/FINS PROCESS

When running away, truancy, or other ungovernable behavior becomes unmanageable, parents should first seek the assistance of counselors or others. Specialists can provide not only guidance to the child but also parenting strategies to help deal with the situation. When those initial efforts fail, parents should contact the agency that is the CINS/FINS provider for Pasco County, Youth and Family Alternatives (listed in this guide).

CINS/FINS stands for Child in Need of Services/Family in Need of Services and is the classification that allows the state to become involved in resolving a family's problems. After contact is made with Youth and Family Alternatives, a screening will take place to evaluate the family's needs. A plan will be developed with the family to address the needs over the next few weeks. Should those efforts fail because of a lack of cooperation by the child, a petition may be filed that will summon the child to civil court and allow a judge to intervene. In many cases the support services offered will help the family solve their difficulties.

EMANCIPATION

Emancipation is a court action which removes the juvenile from parental control and responsibility, allowing the juvenile to function as an adult. A circuit court judge may grant a petition from a parent or legal guardian of a juvenile sixteen (16) years of age or older, after it has been established that the juvenile has the capacity to care for himself/herself. In Pasco County, you can file the court document if you know how to properly prepare the petition. In most cases, a private attorney is retained to petition the court in this type of proceeding. Florida Statute 743.015 addresses this area of law.

BAKER ACT

The Baker Act can be executed if there is a substantial likelihood that without care or treatment the juvenile will cause serious bodily harm to himself/herself or others, in the near future, as observed by recent behavior. An involuntary exam will be conducted if you have reason to believe that the person is mentally ill and because of this illness he/she will cause bodily harm to himself/herself or others.

A Baker Act can be executed by a law enforcement officer, physician, psychologist, or clinical social worker. The juvenile must be seen and evaluated by one of the above and must meet the requirements set forth in the Florida Statutes before they can be delivered to the receiving facility. EX PARTE ORDER

This is a petition that is used if you feel that your child is displaying signs of mental problems that are dangerous to himself/herself or others. This form can be obtained from the Clerk of the Court at the courthouse. When this form is filed, a judge will review the facts concerning the situation. If the judge approves the order, the order is sent to law enforcement agencies for service. When the order is served the child is delivered to the nearest mental health receiving facility for evaluation. The child can be held up to 72 hours.

When the paperwork is obtained at the courthouse, it must be completely filled out. In the section where it asks for your observations, you must go into details. Describe any and all strange behavior, or what he/she has said or done. **Be Specific.** All spaces on this form must be filled out. The child will not be picked up unless the judge approves and signs the order.

MARCHMAN ACT

This is a petition that is used if you feel that your child is a substance abuser (alcohol/drugs). It seeks involuntary treatment of the child.

Before obtaining this form you must first contact a mental health counselor at BayCare. A letter of referral must be obtained from the mental health counselor before the Marchman Act can be used.

After obtaining the form all spaces must be completely filled in. The person obtaining this form will be listed on the form as the Petitioner. The Respondent is the person with the substance abuse condition and the person who will be served. Please **be specific** in the completion of this form. Give full and descriptive details of the incidents and what the child is believed to be abusing. Also add all observations and any strange behavior that the respondent is displaying.
